OFFICE MEMORANDUM

Aizawl, the 16<sup>th</sup> March, 2022

It has come to the knowledge of the Government that some Departments having mega projects neglect to follow the guidelines laid down by the Government for implementation of the projects. This has resulted into wasteful expenditure of scarce public resources and even collapsing of buildings.

Henceforth, all Govt. Departments, Boards/Commissions/Corporations, Govt. of Mizoram Undertakings, Public Sector Undertakings, Banking Institutions and Central Govt. Offices in Mizoram having mega projects are hereby instructed to strictly adhere to the provisions of the 'The Aizawl Municipal Corporation (Site Development and Slope Modification) Regulations, 2017' in relation to the following mandates:-

- 1) To take up complete documentation in the project implementation and maintain proper record of the mega project related documents.
- 2) To carry out soil survey during pre-construction stage for any mega constructions, whether it is a Government owned project or any work undertaken through private construction/firms.
