### VACATION NOTICE

The inspection conducted by Quality Control, Research & Development Division, Public Works Department (PWD) in 2013 had proposed dismantling of all Government Buildings (Quarters) at Ainawn Veng (Then, Govt. Complex) as the structural strength were found unfit to withstand any external forces.

The joint inspection conducted by the Aizawl District Disaster Management Authority (ADDMA), PWD, Disaster Management & Rehabilitation Department (DM&R), General Administration Department (GAD) and Local Council, Govt. Complex in 2022 had proposed immediate evacuation of the occupants and dismantling of Govt. Buildings (Quarters), Ainawn Veng for the safety of the residents and surrounding areas.

Accordingly, the inspection conducted by the Aizawl Municipal Corporation (AMC) in 2022 had also suggested dismantling of the buildings for the safety of general public.

Taking all the suggestions, findings and the inspection reports into accounts, the Meeting of Council of Ministers held on 18th May, 2023 had decided immediate evacuation of the occupants and demolition of Government buildings (Quarters) in Ainawn Veng for the safety of the residents and general public to avoid possible disasters that may occur in future due to the dilapidated conditions of Government buildings.

Therefore, all the allottees/occupants of Govt. Residential Buildings/Quarters viz., Type-I, II, III,& IV are hereby instructed to vacate their respective buildings/quarters within 60 (Sixty) days from the date of issuance of this order by submitting vacation report to this Department. Allottees/occupants are further advised to vacate their respective quarters as early as possible without waiting for the expiry of the given dateline for their own safety.
