Subject: Residential flats for Mizoram Government Employees at Federation Enclave, Luangmual, Aizawl on Ownership Basis.

The State Government is aware of the acute shortage of residential accommodation for government employees in Aizawl city. Despite continuous efforts, the demand for government quarters continues to exceed the available supply, resulting in a large number of pending applications.

In order to partially address this issue and to improve availability of residential accommodation for government employees, the Government of Mizoram has allotted land at Luangmual to the Mizoram Government Employees Housing Society (MGEHS) for construction of residential flats on a permanent ownership basis.

The said project, titled *Federation Enclave*, is currently under construction. The flats are available for purchase on a **first come, first serve** basis. The ownership of the flats shall be legally transferable through registered deed of apartment in accordance with relevant provisions of the Mizoram (Land Revenue) Act, 2013 as amended.

Due to the limited number of flats and the high level of interest received, all interested government employees are advised to apply at the earliest. To assist prospective buyers in making informed decisions, sample flats are presently open for inspection at the project site.

All Administrative Departments are requested to bring this information to the notice of their respective directorates, subordinate offices, and all employees, so that eligible individuals are informed and given an opportunity to avail this facility.
