**NOTIFICATION**

Dated Aizawl, the 22<sup>nd</sup> November, 2021

In continuation to this Department's Notification No.B.11020/1/2019-GAD dt.20.1.2020 and in the interest of public service, the Competent Authority is pleased to lay down the following **Terms of Reference for the Rehabilitation and Resettlement Board** constituted by the State Government of Mizoram with immediate effect and until further order.

1. The Rehabilitation and Resettlement Board will study and identify unimplemented clauses of the Memorandum of Settlement (Mizoram Peace Accord, 1986) signed by the Government of India, Government of Mizoram and Mizo National Front on 30.06.1986
2. The Board will assess the resettlement needs of individuals, Groups of persons or a community belonging to the category of political sufferers and displaced persons and victims of any unprecedented circumstances other than natural and man-made disasters, and accordingly advise the State Government regarding the nature of assistance required.
3. The Relief and Rehabilitation Board will recommend the nature, scale and quantum of assistance to be provided to various categories of deserving persons or group of persons from amongst underground returnees, political sufferers, displaced persons who may require rehabilitation or resettlement. While making the recommendation, the Board shall ensure that there is no room for disparity in the nature or quantum of assistance to be given to individuals belonging to a similar category and shall not vary from person to person.
4. The Relief and Resettlement Board will take necessary step for merging various entities/ groups of MNF Returnees into a unified single entity for the purpose of consideration of any form of assistance.
5. The Board will draw up a special scheme for the Rehabilitation and Resettlement of those MNF Returnees who, or whose family members, were inadvertently

excluded from the special schemes of the State Government implemented earlier. The special scheme will be moved by the Nodal Department (Disaster Management & Rehabilitation Department, Government of Mizoram) for consideration and approval of the State Government.

6. Persons displaced by infrastructure and development projects who have been provided compensation or relief under the project fund itself and victims of natural disasters who have been assisted under the National Disaster Relief Fund and the State Disaster Relief Fund or any other source of the Central and State Government shall not be included under the purview of the Board.
