Subject: Implementation of the Chief Minister's 100 Days Programme

The Chief Minister had announced a list of 12 points to be achieved by the State government within 100 days right after the swearing in of the new government on December 8, 2023. These 12 points have come to be known as the "Chief Minister's 100 Days Programme".

2. A brief of the Chief Minister's 100 Days Programme (hereinafter referred to as the "programme") is outlined at *Annexure* for reference including additional points subsequently added at the direction of the Chief Minister within the programme.

3. A "Monitoring Committee for the Chief Minister's 100 Days Programme" headed by the Commissioner and Secretary to Chief Minister has also been constituted by the State Government through an order dated 15.12.2023 to closely monitor and review the status of implementation of the programme.

4. The timeline for completion of the programme is fixed as March 31, 2024. Therefore, all departments concerned are informed to proactively initiate steps for prompt and effective implementation of the programme in right earnest and ensure that all the points in the programme are completed before the end of the stipulated timeline.

5. All administrative departments are, further, informed to document all notable initiatives and achievements made by their department in addition to the programme within the first 100 days of the government.

12 POINTS ON CHIEF MINISTER'S 100 DAYS PROGRAMME

1. Year of Consolidation:

The financial year 2024-2025 will be a Year of Consolidation. Therefore, big projects may not be expected during the first year.

2. Minimum Rates:

Minimum rates/minimum support price will be fixed for ginger, turmeric, chilly and broom at which the government will procure it from the producers. However, producers will be free to sell at a higher price elsewhere.

3. Preparation of Budget:

All ministers will be given a roadmap for their respective departments and all departments should prepare ZPM policy oriented budget accordingly. The budget will introduce accurate arithmetic calculations which will reflect the actual current position. Government funds parked in personal bank account, if any, should be resolved by the holder immediately.

4. Resource Mobilization Committee:

Resource Mobilization Committee will be constituted to look into austerity measures (revision/reduction in entitlement of household peon, furniture, vehicles, etc), manpower assessment (issue of substitute employees, reorganization of staff, etc.) and disinvestment.

5. Work Orders:

All issued work orders which were being executed will not be cancelled, however, quality of work will be strictly monitored. All issued work orders which are yet to be executed or any work executed without work order should be stayed with immediate effect. All funds under SASCI scheme which are not yet utilized should be reported by the concerned Nodal Agency.

6. Anti-Corruption Measures:

Mizoram Lokayukta will be strengthened only after careful examination on whether the body is worth strengthening. General Consent will be given to the Central Bureau of Investigation (CBI) at the earliest.

A committee will also be constituted to monitor all projects in the State. It will constitute representatives from all recognized political parties, NGOs, Mizoram Kohhran Hruaitu Committee (MKHC) and Mizoram People's Forum (MPF). Quality Control Division will be formed to provide technical support to the Monitoring Committee. No estimates should be revised without the recommendation of the said Committee.

7. Punctuality and Time Management:

All departments should take necessary action for introduction of Biometric Attendance System at the earliest.

Note: *The Monitoring Committee recommended that biometric attendance system be implemented first in Mizoram Secretariat on a pilot mode within the 100 days programme and the system be subsequently scaled up to all departments up to the district level beyond the 100 days programme. It also further recommended that the system so introduced in all Government departments should be compatible to each other so that they can be integrated and monitored centrally by the Government from one single dashboard. As such, Government Departments may not act independently but wait for further directions before procuring such system on their own.*

8. State Marketing Board:

State Marketing Board will be constituted to deal with procurement of agricultural products, vegetable supply chain, food processing, skill development and entrepreneurship, value addition and other related matters.

9. Boundary Committee:

Boundary Committee consisting of different representatives will be constituted.

10. Dissolution of SEDP Boards, MSSSB and Resource Mobilization Department:

The 15 Socio-Economic Development Policy (SEDP) Boards, the Mizoram Subordinate Services Selection Board and Resource Mobilization Department will be dissolved at the earliest.

11. Mizoram Right to Public Services Act:

The Mizoram Right to Public Services Act, 2015 which was already passed by the Mizoram Legislative Assembly should be implemented by all concerned departments immediately.

12. Anti-intoxicating Substances Drive:

Campaign against use of intoxicating substances will be intensified and budget for the same will also be increased. In this connection, the existing Excise Act will be amended as necessary.

Additional points in the programme:

- a) Cancellation of the sale of land at 24, Ashutosh Chowdhury Avenue, Mizoram House, Kolkata
- b) Allocation of funds for Mizoram State Health Care Scheme
- c) Allocation of funds for procurement of ginger, turmeric, chilly and broom
- d) Finalization of the Mizoram Investment Policy
