## **NOTIFICATION**

A memorandum of agreement had been signed between the Assam Rifles and the Government of Mizoram on October 23, 2024 for relocation of Assam Rifles battalion from Aizawl city to Zokhawsang. The following plots of land are to be handed over by the Assam Rifles to the Government of Mizoram as specified in paragraph 4(a) and 4(b) of the memorandum of agreement:

- i) Chite river (Dhobi Nallah) 62.80 acre
- ii) Church area 0.63 acre along with Assam Rifles Church
- iii) Babutlang 0.453 acre along with Assam Rifles assets
- iv) Lammual 25.94 acre to include the Main Barrack Complex, Unit Hospital and Assam Rifles Ground
- v) Land and Building 1.1 acre of Loch House
- vi) Quarter Guard Hill Complex 14.5 acre of Quarter Guard Hill Complex along with buildings
- vii) School area 1.00 acre along with buildings
- viii) War Memorial and Mandir 0.78 acre

Section 5 of the Mizoram (Restriction on use of transferred land) Act, 2002 stipulated that the land transferred by the Assam Rifles to the Government of Mizoram shall be used by the Government only for "public purpose" as defined in section 2(1)(d) of the aforesaid Act.

The State Government, in exercise of the powers conferred by section 6 of the Mizoram (Restriction on use of transferred land) Act, 2002 as amended, hereby constituted an Advisory Committee comprising of the following members:
