- 1) To ensure that guidelines, instructions for the projects and programmes issued by the Authority concerned are strictly followed.
- 2) To ensure coordination among all Departments, Agencies, etc. involved for timely completion of the projects and programmes and to provide update in the portal concerned.
- 3) To monitor progress, identify issues, problems and resolutions thereof.
- 4) To monitor all land acquisition cases pertaining to major infrastructure projects like National Highways, Railways, etc.

- 5) To ensure that all necessary clearances such as Forest Clearance, Environment Clearance etc. are obtained on time and such clearances do not delay scheduled progress and completion of the projects and programmes.

The committee shall meet at least once a month and submit report as and when required.
