**NOTIFICATION**

**No. D. 11031/7/2016-GAD:** In pursuance of Para II (1) of the minutes of the meeting of the Council of Ministers held on 30.09.2019 conveyed vide Memo. No. J. 11011/1/2019-POL/Vol-IV dt. 3.10.2019 and as per the observation of Finance Department (B) tendered vide I.D. No. FIN(B) 965/2019-20 dt. 22.10.2019, the Governor of Mizoram is pleased to make the following amendments to **Para 12 & 18 of "The Mizoram Government Land Pooling and Management Scheme"**

**I. Para 12 : Budget Provision:**

*Separate Funds with separate head of accounts shall be provided to meet various expenditures in connection with management of government lands, government complexes and housing complex.*

*12.1 General Administration Department at the State Level: Funds shall be placed in the General Administration Department for utilization through the Estate Cell.*

*12.2 Deputy Commissioners at the District level: Funds shall be placed under the Deputy Commissioner, for utilization through the Estate Cell (Lands & Buildings). Appropriate Head of Account, along with the amount of funds shall be decided by the Government from time to time.*

**II. Para 18. Collection of Taxes on Government Lands:**

*Taxes on Government Lands shall be levied and paid as per the existing rate by the State and Central Government concern.*

*In respect of the Government of Mizoram, all the revenues payable by all the Departments shall be levied by the Land Revenue & Settlement Department through the State Level Government Land Authority (State Estate Cell) in the State level and the District Level Government Land Authority in the Deputy Commissioner's Offices. Payment shall be made by the State Level Government Land Authority (and the District Level Government Land Authority).*

*The required funds for payment of land revenues of all Government land shall be provided by Finance Department (Budget) to the State Level Government Land Authority (and the District Level Government Land Authority and the land revenue shall be directly remitted to revenue head of Land Revenue & Settlement Department through challan in the treasury.*
