ORDER

Whereas the Council of Ministers in its meeting held on May 18, 2023 decided to immediately evict the occupants/allottees of Type-I, II, III & IV Government Quarters at Ainawn Veng and the subsequent demolition of the aforesaid Government Quarters in phases to ensure the safety of the residents and the general public from possible disasters owing to the dilapidated condition of the buildings.

Whereas the occupants/allottees of Type-I, II, III & IV Government Quarters at Ainawn Veng were notified to vacate their respective quarters within 60 days vide notice of even number dated 22.06.2023 with a condition to vacate as early as possible without waiting for the end of the dateline i.e., August 22, 2023.

Whereas the State Government ordered the demolition of the following Government Quarters in the first phase on priority basis and immediate vacation by the occupants/allottees vide order of even number dated 18.08.2023 on account of the extremely deteriorated structural conditions of the buildings.

Whereas the State Government extended the dateline for the occupants/allottees to vacate their quarters up to December 31, 2023 vide notice of even number dated 18.08.2023 in consideration of the prayers submitted by the occupants/allottees as well as from the Joint NGOs.

Whereas a representation dated 17.11.2023 to extend the dateline for vacation of the Government Quarters with a bond to be signed by the occupants/allottees that they be held fully responsible in case of any disaster was received by the State Government from the representatives of the Government Quarters Allottee Welfare Committee, Ainawn Veng.

Whereas the State Government considered the plight of the occupant/allottees and the difficulty in finding suitable alternative accommodation within a relatively short period of time.

The Competent Authority, hereby, extends the dateline for vacation of Type-I, II, III & IV Government Quarters at Ainawn Veng by the occupants/allottees until further orders except the occupants/allottees whose quarters have already been ordered by the State Government to be demolished in the first phase vide order of even number dated 18.08.2023. Notwithstanding this further extension, the occupants/allottees are advised to vacate the quarters for their own safety and in the interest of the general public as early as possible.
