ORDER

In spite of repeated instructions issued by the Government regarding the prohibition of animal rearing within the premises of Govt. Quarters under General Pool/AIS Transit Accommodations, it has come to the notice of the Government that such illegal activities has increased significantly in recent times.

As such, this is a reminder to all concerned that animal rearing for commercial purposes or personal consumption within the premises of Govt. Residential Quarters/AIS Transit Accommodations is strictly prohibited. Necessary action shall be taken against those failing to abide by this Order, and may also result in cancellation of the allotment order in respect of allottees of Government Quarters/AIS Transit Accommodations.

Therefore, allottees/outsideers currently rearing poultry/livestock (Pigs, goats, cattle, etc) within the said premises are instructed to shift such activities outside the above-mentioned premises before the expiry of September, 2021. Pet dogs shall be tied or kept in a safe place where they cannot cause any harm or hardships to others.

Further, it has also come to the notice of the Government that vacant lands within the premises of Mizoram New Capital Complex (MINECO) as well as those in other Government Quarters/ AIS Transit Accommodations are being utilized as Makeshift Vegetable/ Kitchen Gardens. Utilization of Government land for such purposes is strictly prohibited. Therefore, those involving in such activities are instructed to stop their activities immediately.

All Administrative Departments/Head of Departments, Govt. of Mizoram are requested to circulate this Order to Officers and staffs concerned working under them. Further, all Local Council Chairmen under whose jurisdiction these Government Quarters/AIS Transit Accommodations fall, are requested to extend their assistance in preventing Govt. land and properties from being used for such unwanted activities.
