Further, proposal for engagement of personal staff of the Vice-Chairman shall be taken up by the concerned Department and correspondingly, for Veterinary, Fisheries and Sericulture Board and Sports, Youth Affairs and Tourism Development Board, AH & Vety Department and Sports & Youth Services Department shall take up the engagement of personal staff respectively.


